1. Call to Order and Pledge

The Chair called the meeting to order at 5:00 p.m.

8. Track and Field Coach and Program

Dan Campbell gave a presentation about the track and field program for which five students have chosen to participate. He explained the costs associated with the program including an annual fee to the regional association. We will not be hosting any meets. Each meet will cost between \$350-\$600 and there are five regular season meets. Uniforms are \$458. Equipment will cost \$2,000 (javelins, hurdles, starting block, measuring wheel). Superintendent Collins said the school will absorb this nearly \$6,000 of startup costs through unexpended budget funds and, if needed, will ask the Board to transfer funds from one cost center to cover the overage in extra-curricular.

The Superintendent recommended Jason Mills for the position of track and field coach for the 2023-2024 year.

The School Committee voted (9-0-0) to approve the recommendation.
