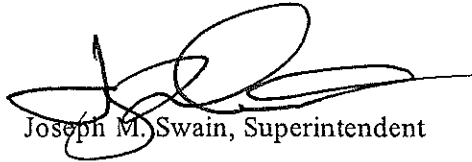
6. New Business
