A meeting of the Moosabec CSD School Committee was held at Jonesport-Beals High School on July 18, 2018 with members present as follows: Julie Farris, Ernest Kelley Jr., Clifford Norton III, Mariner Bunker, Debbie Kelley and Wilma Jones (6:00 p.m.) Also present were Principal Michael Kelley and Superintendent of Schools Denis Howard.

Ernest Kelley Jr. called the meeting to order at 5:35 p.m.

1. Pledge of Allegiance

The Superintendent opened the meeting with the Pledge of Allegiance.

2. Approval of Minutes of July 3, 2018

The School Committee voted (5-0-0) to approve the minutes of July 3, 2018.

3. Request for Proposals – Roof

The School Committee reviewed the following proposals:

The School Committee voted (4-0-1) to award the project to Adam Willette.

4. Miscellaneous

A. Letter of Resignation

A letter was read from Elizabeth Nichols-Goodliff resigning from her part-time music teacher position.

The School Committee voted (5-0-0) to accept the resignation with regret.

B. Regional meeting on CTE

The Superintendent highlighted the regional meeting on CTE courses held at NHS on July 17th. He distributed a handout summarizing the meeting (see attached).

C. Leave of Absence

The Superintendent informed the School Committee that Terri Crowley will be on medical leave for a minimum of three months. He indicated that he is awaiting written documentation and will keep the Board apprised.

D. Dead River Discount Offering

F. Request for Proposals – Project Learning Building

First, Julie explained the \$2,000,000 insurance rider and the Superintendent indicated he will adjust the dates and run the ad for another week. Proposals to be accepted up until noon on July 31, 2018. The contractor shall complete work by January 1, 2019.
