A meeting of the Jonesport School Committee was held at the Superintendent of Schools Office on Wednesday, March 01, 2017 with members present as follows: Julie Farris, Ernest Kelley, Jr. and Clifford Norton, III. The meeting was called to order at (6:19) p.m.
